## Who Needs a HOA?

Have you ever wondered why you have a homeowners association? You may not realize it, but your association may be the only thing that protects the value of your home or the quality of your neighborhood.

Community associations do a number of different things. They set and collect the maintenance fees needed to run neighborhood operations. They may maintain landscaping or recreation centers. They may provide for events or meeting places for neighborhood functions. However, the most important function of an association is to enforce deed restrictions

Deed restrictions are legally binding rules, filed with the real property records, which provide for building, maintaining and using the homes in your neighborhood. They control how homes look and what can be done in the subdivision.

Think for a moment about why you bought your home in the first place. You may have liked the curb appeal of your house or its floor plan, but you probably also considered the neighborhood - how the houses looked next door and down the street. You bought the neighborhood at the same time you bought your house. You bought a lifestyle and surroundings which were much larger than your own property, encompassing everything from the subdivision entries and the recreation center to all the other homes in the neighborhood, assuming it would stay that way.

Unfortunately, many subdivisions don't stay as nice as when they were new. Just like a home, a neighborhood can be well maintained or it can be allowed to fall apart. The big difference between an attractive and an unattractive neighborhood is not really the deed restrictions. Most neighborhoods have reasonably good deed restrictions. The crucial factor is the willingness of the men and women who make up the association's board of directors to enforce the rules that you do have.

What could happen if you don't enforce your restrictions? Plenty! People can amaze you with what they will think is acceptable in a neighborhood. Your subdivision could become a real zoo. Consider the man who kept a full grown lion in his garage, or the couple who kept four or five monkeys in their backyard. Of course there's always the usual demand for goats, chickens and pigs. These are all real cases where one person's idea of what is acceptable probably differs (Continued on Page 6)

### Honey, It's Those Neighbors, AGAIN!

Neighbors. Every one's got some! You might be surprised to realize you are one. Neighbors become your best rear guard or your worst nightmare! Which are you? Have you met your neighbors? Do you know their name? What about the people across the street? Yeah, how about those people across the street!

Often times, the health of a community depends on how neighbors treat each other. Ideally, all of us should live with each other with mutual respect, honor, and concern for one another. Think about those words for a moment. Respect. Honor. Concern. When is the last time you gave or received any of those things to or from your neighbors?

You know those "good old days", when people welcomed each other into the neighborhood, or brought over the best brownies and homemade apple pie when someone had surgery, or to get acquainted. People would call on each other just to see how they were doing, or why they were missed at church on Sunday, or why senior Mr. Jones hadn't been seen picking up the newspaper for 3 days. Times were tough in the distant days of settling our beloved America, but folks found time to watch out and care for each other. They had events such as house raisings, when the folks would get together in the community and actually rebuild a house that had burned down, or gathered to build a church or a school, or a home for a newly wed couple. Veterinarians, Doctors and Clergymen made house calls; some still do. We still have the same need to have a sense of community, to care for our neighbors and to be a neighbor.

No one person can be a community, but one person can make the difference! Check on your neighbors. Lend a hand. Watch out for suspicious activities. Tell those kids to get out of the street! Tell those speeding through the neighborhood to slow down! Ask those teenagers, do your parents know what you are doing? Tell the parents! Get the names and phone numbers of the neighbors around you so you can make that quick phone call. Crime rates could drop if we kept that up for a year!

At some point, you or your neighbors are going to do something that becomes a nuisance. If your neighbor is doing something that is affecting you, then go and meet your neighbor and kindly talk to them about your concern. Don't sit at home and "stew" with contempt and frustration. Communicate! And, in turn, when your neighbor comes to you with a concern, don't blow them off. Listen. Respect them & evaluate the issue to see if there is something you can do differently. If you have to compromise, it's not going to kill you. After all, it is the neighborly thing to do. Protect your neighbor to neighbor relationships; they could be one of your best assets.

#### Nuisances: The Last Resort

If you're faced with a nuisance that will not stop, there is something you can do. The recommended approach is to try and work things out with your neighbor. (If your dispute concerns a deed restriction issue, the neighborhood association may be able to help you. Disputes with neighborhood association's area of authority. You can check with PCMI, the Association's Management Company to see if there is a deed restriction issue). In other cases you may have legal remedies, for which it is best to consult a competent attorney for legal advice. One legal remedy may be filing a Nuisance Complaint with Judge J. Kent Adams, presiding Justice of the Peace for Precinct 4, Position 1, located at 6831 Cypresswood, Spring, Texas 77379 . ## **Pilgrim Cap Place Cards**

What you'll need: 3 inch terra-cotta flowerpots Craft foam: black, yellow, green and purple Scissors Acrylic paints in black, white, red, green, and blue Thick white craft glue: black fabric paint pen



Thick white craft glue; black fabric paint pen Paint the entire pot black and allow it to dry. Choose a color to

paint the entire pot black and anow it to dry. Choose a color to paint the band around the top of the pot. Let it dry. Make white dots on the rest of the pot by dipping the handle of a paintbrush in white paint and dotting on to the surface.

Cut a circle from black foam. Cut it about <sup>1</sup>/<sub>2</sub> inch wider all around than the pot opening. Use an appropriate size dish, cup or lid to trace. Place a small amount of glue on the rim of the pot and glue onto the black foam circle.

To make the buckle, measure the width of the band of the pot (the portion painted a different color). Cut a rectangle out of foam that measures about 1/8 inch deeper than the band on the pot. Glue it to the band. Let the glue dry.

Use a black paint pen to write the guest's name on the colored band. Allow it to dry before using. *Happy Thanksgiving!*

### **Pumpkin Cake Roll**

- 3 eggs 1 cup granulated sugar 2/3 cup pumpkin 1 tsp. lemon juice 3/4 cup flour 1 cup finely chopped walnuts
- 2 tsps. cinnamon 1 tsp. ginger ½ tsp. nutmeg ½ tsp. salt 1 tsp. baking powder powdered sugar

Beat eggs on high speed for 5 minutes. Gradually beat in sugar. Stir in pumpkin and lemon juice. Stir together flour, baking powder, cinnamon, ginger, nutmeg, and salt. Fold into pumpkin. Spread in greased and floured 15 x 10 x 1" pan. Sprinkle with the finely chopped walnuts. Bake at 375 ° for 15 minutes. Turn out onto a towel which has been sprinkled with powdered sugar. Starting at narrow end, roll. Cool.

#### Filling


1 cup powdered sugar 2 - 3 oz. pkgs. cream cheese 4 tablespoons margarine 1<sup>1</sup>/<sub>2</sub> tsp. vanilla

Beat smooth. Spread over cooled, unrolled cake. Roll and chill. Slice. Very good and keeps well in refrigerator!

from what you want in your own neighborhood.

Another consequence of inaction is that your neighborhood could become an architectural showcase for the weird and unusual. Take, for example, the man who painted his brick home black and orange, alternating each brick with one painted orange and the next one painted black. Or just imagine a vivid assortment of day glow blue, purple or pink houses down your street. People have differing views of what is attractive and, without deed restrictions, you have a good chance of your neighborhood looking dramatically different from the way it did when you bought your home.

What about commercial use of the properties? Again, you may be surprised. How would you feel about a portable toilet company keeping its toilets and cleaning them on the driveway next door? Or what about a big semi tractor-trailer truck parked across the street? Or people in every business under the sun operating out of their homes? It all happens and the only way you can preserve the lifestyle you thought you were buying is to enforce your deed restrictions. Without restrictions some people would leave garbage in their yards permanently, never maintain their homes, park their cars and boats on the grass in their front yards, park motor homes in the street for years, leave construction unfinished, and make every kind of bizarre, structurally unsound remodeling project you can imagine.

These are real examples of problems faced by many local subdivisions in the last ten years. If the deed restriction violations are not corrected, there can be very negative results. Dr. Barton Smith of the University of Houston Center for Public Policy estimates that property values in a subdivision with an inactive association can fall as much as forty percent due to failure to enforce restrictions.

To illustrate, multiply an average home price of \$50,000.00 times the number of lots in an average subdivision of 250 homes. This yields a total property value of \$12,500,000.00. This is the value of the assets that the association is trying to protect. If that property value is reduced by forty percent, the homeowners in the neighborhood lose \$5,000,000.00. Obviously, this is a disaster. Even worse, think about living in a subdivision that deteriorated that badly!

Even if home prices only lose ten percent in value due to a moderate failure to enforce deed restrictions, homeowners lose \$1,250,000.00.

That kind of loss is simply unacceptable and completely unnecessary. The association, acting through its board of directors, can control the appearance of the neighborhood by taking deed restrictions seriously and vigorously enforcing any infraction of those restrictions.

Failure to enforce your community rules is like allowing a bacterial infection to go unchecked. At first it may appear to be a small problem, but it soon spreads and becomes very serious. Like getting a shot or taking medicine, enforcing deed restrictions can be unpleasant, but it is necessary for the health and vitality of your neighborhood. *Copyright W.
