

I, \_\_\_\_\_, including any other user of my access card, i.e., family members, guest, etc., have enrolled in a program of strenuous physical activity including, but not limited to, aerobic dance, weight training, stationary bicycling and the use of various aerobic-conditioning machinery offered by the Cypress Mill Fitness Center. I hereby affirm that I am in good physical condition and do not suffer from any disability that would prevent or limit my participation in this exercise program.

I understand that the agents' and employees of Cypress Mill Homeowners Association, Inc. (herein, the "HOA") may provide instructions regarding the use of the equipment and/or weights, but such agents and employees are not trained to evaluate whether I am suitable to participate in any particular program or to determine what level of physical exertion may be appropriate for my body. I am not relying upon the HOA or any of its agents or its employees for any purpose with the regard to whether I am in an appropriate physical condition in this exercise program.

I FULLY UNDERSTAND THAT I MAY INJURE MYSELF AS A RESULT OF MY PARTICIPATION IN THE EXERCISE PROGRAM. IN CONSIDERATION OF MY PARTICIPATION IN THE EXERCISE PROGRAM, AND TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, I HEREBY AGREE TO RELEASE, INDEMNIFY, PROTECT, HOLD HARMLESS AND DEFEND THE HOA AND ITS LEGAL REPRESENTATIVES, MEMBERS, PARTNERS, OFFICERS, DIRECTORS, EMPLOYEES, AND AGENTS (COLLECTIVELY, THE "HOA AFFILIATES" FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, DAMAGES, INJURIES, LOSSES, LIENS, CAUSES OF ACTION, SUITS, JUDGMENTS, LIABILITIES AND EXPENSES, INCLUDING COURT COST AND ATTORNEY'S FEES OF ANY NATURE, KIND OR DESCRIPTION (INCLUDING WITHOUT LIMITATION, CLAIMS FOR PROPERTY DAMAGE, INJURIES TO OR DEATH OF ANY PERSON OR ENTITY, SUCH AS HEART ATTACKS, MUSCLE STRAINS, PULLS OR TEARS, BROKEN BONES, SHIN SPLINTS, HEAT PROSTRATION, KNEE, LOWER BACK OR FOOT INJURIES AND ANY OTHER ILLNESS, SORENESS OR INJURY, HOWEVER CAUSED) OCCURRING DURING OR AFTER MY PARTICIPATION IN THE EXERCISE PROGRAM OR USE OF HOA FACILITIES. Our mission as the Board of Directors of your homeowner's association is to:


1. Develop programs, resources, and financial strategies to maintain and improve the community,





Season begins 5/19, first dual meet 5/21, divisional meets 6/25, end of season 6/27, post season invitational meets 7/2&3.

Cypress Mill will be in division 14 with the following communities:

Estates of Highland Creek, Stone Gate, Glencairn, Chimney Hill, Cypress Point.

Registration will be held at the Activity Center on Saturday, April 2 & 9.

### Swim Team Officials Needed

All training is provided free of charge.

### Stroke and Turn:

This position is one of the most important positions needed. The team will need approximately seven Stroke and Turn officials. Persons in this position will watch the swimmers and look for violations in swim stroke and turns.

An individual who wishes to become a new Stroke & Turn Official must attend a Stroke & Turn lecture and a subsequent On-Deck session. The Stroke & Turn lectures generally take about 2½ - 3 hours and cover the NWAL Rule Book with particular emphasis on the various strokes. After attending a lecture, the candidate will attend an approximately 60 minute On Deck session where the various strokes

will be demonstrated in the pool, and positioning will be discussed. At the end of the On-Deck session the candidate may take the Stroke and Turn test.

### Starter:

The starter will be responsible for the beginning of each swim heat.

Candidates must attend an evening 1½ - 2 hour classroom session **prior** to the Saturday on-deck lecture (45 minutes), and then pass a written test (30 minutes) held on Saturday. The lecture covers the referee and starter sections of the rulebook. The on-deck session will give prospective starters a chance to practice their skills with a microphone.

### Referee:

Referees will have full authority over all Officials and enforce all the rules.

An individual who wishes to become a Referee must attend one of the evening referee lectures, an on-deck session, and then pass a written test. The classroom session lasts about 2½ - 3 hours. The entire rulebook and both referee and starter situations are discussed. The on-deck session (60 minutes) and test (30-45 minutes) are held

on Saturday mornings.

In order to be certified as a Referee, the candidate must also have a minimum of 1 year experience as a Stroke & Turn Official and as a Starter. The only exceptions to this requirement will be for new teams who do not have a referee or existing teams who have lost all of their referees through attrition. "Hardship waivers" for these situations must be requested by the Referee candidate in advance of the NWAL season.

### Announcer:

This person should be energetic and will be announcing the swim meet events.

### Clerk of Course / Computer:

This position will enter swim times throughout the meet. Two – three persons are needed.

Since many of the rules that apply for Clerk of Course also apply during use of the Hy-Tek software, this course has been modified to address both the Clerk of Course and Computer entry positions. The designation is **Clerk/Computer**. The individual who desires to be certified needs to attend a lecture lasting approximately 1½ hours. The lecture covers the applicable rules for entry and running the meet. There is no test associated with this certification. **It is required that your Clerks and head computer personnel be certified as Clerk/Computer.**

### Times and Scribes:

The timers will time the swimmers and the scribes will record the times. Several persons per meet are needed.

### Concessions:

This positions requires reliable persons who work well with money. Two persons are need per home meet.

### Ribbon Writers:

Distributes ribbons.

## Noise Ordinance

There is no noise ordinance in Harris County. There is, however, a Disorderly Conduct (Loud Noise) ordinance. This ordinance can be for any noise that is annoying, harassing, or alarming to be to loud. Under Disorderly Conduct, you can contact the Constable's Office and an Officer will respond. The Officer will ask the offender to lower the noise.

Another option is for the offended person file a criminal complaint for the loud noise. This complaint is filed at the Precinct 4 Justice of the Peace office at 6831 Cypresswood Dr.. The offender is then issued a criminal citation from the court and is fined money if found guilty.

Also check your deed restrictions for any restrictions against noise. In some sections, there is an offensive activity clause which prohibits offensive noise before 7:00 a.m. or after 9:00 p.m. In this situation, contact the Management Company.

## Local Charities Benefit from Chamber Support

A number of local charities benefited from donations by the Cy-Fair Houston Chamber of Commerce according to President Darcy Mingoia at the group's monthly membership luncheon.

"We have had a direct financial impact on local non-profits working to better our community," Mingoia said. "We provide support to a variety of different organizations," she added.

In reviewing recent donations, Mingoia explained that the Chamber Herd has donated more than \$50,000 to Cy-Fair ISD FFA Students in the last five years and a total of \$82,000 since the program began ten years ago. Meat purchased in the auction is then processed and donated to area ministries. "In the case of the Chamber Herd, two groups are helped, the FFA students raising the animals and community families in need," Mingoia pointed out. "In addition, unlike other events, all funds raised are donated to those causes," Mingoia added.

In the other annual events held by the Chamber, a portion of the proceeds benefit local charities, she explained. "Our percentage of support is never less than ten percent and in the case of the Economic Development Golf Tournament it is 25 percent," she added.

The Economic Development Golf Tournament benefits the Adam Skinner Memorial Scholarship of the Cypress Fairbanks Educational Foundation. The Chamber has given \$39,500 to the scholarship fund over the past six years. Since 1999 one graduate has been awarded the Adam Skinner Memorial Scholarship each year.

The Annual Bowling Tournament helped fund the Cy-Fair Houston Chamber of Commerce Founding Endowment. The annual tournament was begun in 2002 and its proceeds have been combined with a number of personal donations and sponsorships to complete the required \$15,000 balance. Starting in September 2005, a student will receive a \$1,500 scholarship in the Chamber's name to attend Cy-Fair College.

Other charities that have benefited include:

- Area Ministries have received over \$8,500 in the past five years from the annual Spring Swing Golf Tournament.
- Cy-Fair ISD Junior Achievement Exchange City Program has received \$10,000 in the last four years from the annual Business EXPO.
- The Cypress Creek Fine Arts Museum project received \$5,000 from Chamber members as a special "challenge grant" from Michael B. George, CPA.
- Leadership North Houston is the beneficiary of almost \$5,000 in the last three years.

Mingoia said that normally the local non-profits assist by providing volunteers on the day of the events. Sometimes the non-profits' employees or volunteers also work on the Chamber's event committees where they assist in a variety of capacities. In addition to those volunteers, many Chamber members solicit sponsors, auction items and participants for all the events.
