Cypress Mill Homeowners Association, Inc. Annual Meeting Of Members - April 6, 2005

The Annual Meeting of Members was held on at Wednesday, April 6, 2005 at 7:00 p.m. at the SPJST Lodge located at 17810 Huffmeister, Cypress, TX.

At 7:00p.m. Susan Vandagriff announced that there was not a quorum of owners present in order to officially call the meeting to order however, quorum was established later with 156 owners present either in person or by proxy

Susan Vandagriff, representing VanMor Properties, Inc. introduced Board Members present: Chris Gilbert, Chairman, Chris Forrest and Geneva Fritch, Administrative Assistant: Gisel Ocanas, and guests: Deputy Blackledge and Alex Handley, representing Cypress Hill MUD.

The floor was then turned over to Deputy Blackledge who provided the Constable's report. The following items were discussed:

- Speeding in the neighborhood.
- Burglaries of vehicles.
- Mounted patrol.
- ATV's

Chris Gilbert gave an update on projects the Board worked on during the past year and also discussed future projects.

Alex Handley presented a petition for homeowners to sign in order to get the County to post signs in Section One which would prohibit commercial vehicles from parking in the neighborhood. Once the required number of signatures, which is 25% of all property owners within Cypress Mill is obtained, the petition will be given to the County.

Mr. Handley then discussed the various improvements the MUD will be doing within Cypress Mill.

Mr. Gilbert reviewed the financial statements as of March 31, 2005.

The next item on the agenda was the election of three directors. Chris Gilbert opened the floor for nominations. Amy Merrill, Stephen Howard and Rodney McNabb made up the slate of candidates. The candidates were then given an opportunity to introduce themselves. Homeowners were then asked to cast their vote for two candidates. Stephen Howard and Amy Merrill were elected to serve a term of two years.

Chris Gilbert reminded owners to submit their application for home improvements prior to starting any projects and to read the newsletter for important information and phone numbers. He also asked that anyone interested in serving on any of the association committees to sign up prior to leaving the meeting.

The following was discussed during Open Forum:

- Chris Gilbert gave an update on the tree replacement project along Cypresswood.
- Owners who back up to the detention ponds need to maintain their back yard fences.
- Additional Constable's patrol needed.
- Portable basketball goals in the streets.
- Soliciting in the neighborhood.
- The Board needs to make communication a top priority.
- County Leash Law.
- Enforcement of deed restrictions.

There being no further business, the meeting was adjourned at 9:15pm.

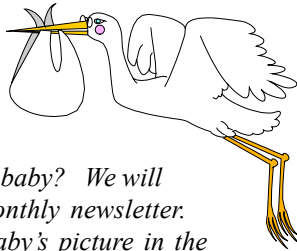

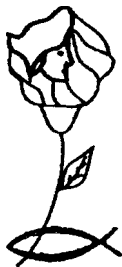

Fireworks Safety

July 4th and New Year's Eve can be an extremely stressful time for your pet due to the loud noises.

As many pet owners know, fireworks and thunder storms can cause a great deal of stress for some animals. Commonly seen signs include:

- Shaking, trembling
- Barking, howling
- Trying to hide or get into/out of the house, fence, or other enclosure
- Refusing to eat food
- Some animals may lose bladder or bowel control or experience temporary diarrhea from prolonged stress

Practice Pet Safety

- **Keep your pets indoors.** It is advisable to close the curtains and turn on the TV or radio to provide some distraction. A quiet place, such as a carrier or a closet, may provide your pet with a sense of security and comfort.
- **Use a leash or carrier.** If you must be outside with your pet, keep the pet on a leash or in carrier at all times.
- **Practice fire safety.** Keep pet away from matches, open fires, and fireworks - especially ones that are lighted on the ground. Pets may try to sniff (or eat) fireworks, and pet hair can easily catch fire if too close to the fireworks.
- **Take your pet for a walk first.** If possible, make sure that you pet has time to "use the restroom" before the fireworks start. Some pets are too frightened to void once the fireworks begin, and this may lead to an "accident" later on.
- **Make sure pet ID is current.** Make sure that your pet has proper identification tags, with current information, in case he/she gets away. This will help the local authorities (who are quite busy this time of year handling frightened runaways).

What can I do if my pet is frightened of fireworks and thunder?

Some animals do fine and don't seem to notice the fireworks. Some do well with just having their owner near, talking in a soothing voice and petting or holding the pet. And then there are some pets that cannot be calmed by petting or talking to them - they are simply too upset. Animals that are frightened/stressed can hurt themselves and possibly escape if left alone, and the results can be fatal. Frightened animals running loose are in great danger of being hit by a car.

For these animals, it is best to provide a safe place, such as a carrier, to be in while the fireworks last. This alone may be enough of a comfort to soothe some pets. If the carrier is not enough to calm the animal, medication (in the form of a tranquilizer) may be warranted. Tranquilizers are not for every pet. Some pet owners have found that herbal remedies to help calm their pets. Talk to your vet about medical options that are suitable for your pet.

Keeping Swimmer's Ear At Bay

If you've ever had swimmer's ear, chances are you've wanted to pull the plug on the pain.

"When water is trapped in the ear canal for a long time, the skin barrier is weakened," said Dr. Jeffrey Vrabec, an associate professor of otorhinolaryngology at Baylor College of Medicine in Houston. "Bacteria can then enter the skin, causing an infection that can become very painful."

Swimmer's ear, or otitis externa, is an inflammation of the outer ear that is most often caused by the accumulation of excess moisture from swimming or daily showering. Symptoms of swimmer's ear include swelling, redness, itching, muffled hearing and/or discharge from the ear. Antibiotic drops are used to treat the condition, and pain can be lessened by applying a warm cloth to the ear or by using a heating pad.

Sleep Could Be Key To Weight Management

Counting calories? Try counting sheep as well. A good night's sleep is important in fighting obesity, says a psychologist at Baylor College of Medicine (BCM) in Houston.

Dr. Kenneth Goodrick, associate professor of family and community medicine at BCM believes the energy enhancement approach works best when people get about eight hours of sleep. He urges those who suffer from sleep-related breathing problems (apnea) to seek a physician's help. Eventual weight loss often can help alleviate sleep apnea.

For general sleep difficulties, he recommends these tips:

- Start with a comfortable mattress
- Set a regular bedtime routine
- Create a pleasant sleep environment
- Have your evening meal at least four hours before bedtime

"Sleep is a vital component in a three-step cycle which I call 'an energy enhancement approach to weight management'," Goodrick said. "This approach looks at sleep, nutrition and exercise as the foundation for high 'perceived' energy."
