Restrictions On Signs

Signs, mostly roofing contractor signs, seem to be pooping up all over our neighborhood. This has resulted from the hail damage that occurred on March 25, 2005.

Your Board of Directors reminds all owners and residents, however, that all signs, with very limited exceptions, are prohibited by our restrictions.

A construction site identification sign is allowed, but this is only during the time of active construction, including repairs. Owners are reminded that commercial advertising signs for contractors before or after active construction are not allowed.

And one For Sale or For Lease sign is allowed per residential lot that is for sale or lease, but owners are reminded that off-site directional signs are not allowed at any time.

Also, since the political campaign season is near, all owners and residents are reminded that political signs are prohibited at all times.

The restrictions on signs and exceptions thereto can be found on page 16 of our Second Restated Declaration of Covenants, Conditions and Restrictions in Article VIII Permitted Used and Restrictions, Section 18. Signs. If you have any questions regarding signs you can call any director or come to our Board meetings

Thank you for your cooperation and for helping to keep the Courtyard a beautiful community.

That the office building mailbox at the corner of Scout Island and Courtyard has a mail pick-up at 10:00 a.m. Mon-Fri?

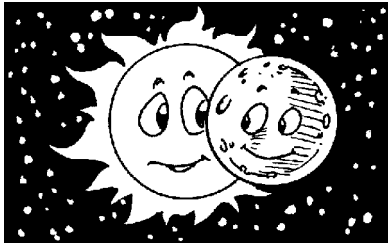
The speed limit in the Courtyard is **30** mph? We need to be conscious of all the little ones in our neighborhood and drive carefully at ALL times.

If you don't receive the local paper, you must call before 10:30 a.m. to get same day delivery? Otherwise they will deliver the next day or credit your account.

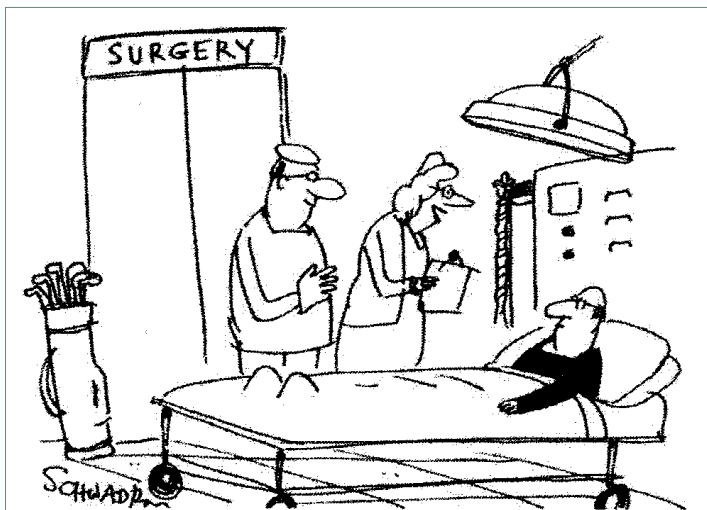

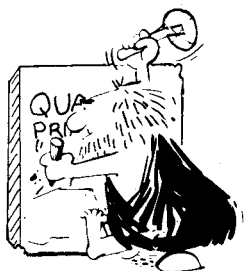

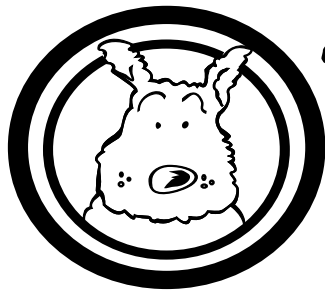

Dogs for the Environment

Why? Pet waste is more than smelly and unsightly: it is a health risk to pets, creeks, lakes, and people, especially children. Pet waste left on trails, sidewalks, streets, and grassy areas are immediately flushed into the nearest waterway when it rains. Like human waste, animal waste may contain harmful bacteria and viruses, making the water unfit for irrigation, recreation, or other uses. These bacteria and viruses can pose health risks to humans, such as Campylobacteriosis and Salmonellosis. In addition, pet waste contains nutrients that will speed up the growth of nuisance algae in lakes and rivers.

"It shall be unlawful for any person to fail to promptly remove and dispose of, in a sanitary manner, feces left by a dog or cat on property, public or private, other than the premises of the owner or handler of such dog or cat."

The Watershed Protection and Parks & Recreation Departments have teamed up to help clean up parks and trails. Look for Mutt Mitt dispensers in many of your favorite parks including the Town Lake Hike and Bike trail. Mutt Mitts are designed to make scooping poop painless. Simply follow the directions on the dispenser box and throw the bag in the trash. The bags are biodegradable. If at home, your grocery bags will work.

Here are ways to keep pet waste out of local waterways.

1. Flush it.
2. Toss it. (in the trash)
3. Bury it.

(If you bury it, be sure that it is at least 6 inches deep, and away from gardens and water sources)

Heart Gallery Of Central Texas

Everyday 500 Central Texas children who were abused or neglected are waiting to be adopted from foster care. Each month, another 30 children currently living in foster care become eligible for adoption, which happens when a parent's or parents' legal rights are terminated. Many children are older or have special needs, are minorities or members of a sibling group. All are considered hard-to-place children.

The Heart Gallery of Central Texas creates a window into the worlds of these children's lives and aims to elicit public support for and interest in adoption from foster care.

The Heart Gallery of Central Texas is a special project of the Adoption Coalition of Texas and CASA of Travis County. Both agencies share the common interest of finding "forever families" for children in foster care who are legally free for adoption. What does legally free mean? Legally free means these children have been removed from their homes due to abuse or neglect, and their biological parents have had their parental rights terminated, and thus, these children are wards of the State of Texas.

The Heart Gallery of Central Texas is an art exhibit featuring more than 100 children who are waiting for adoption. These are children living in the foster care system, and are wards of the State of Texas. These are children longing to be a part of a family. In January of this year, the Parade Magazine published a story about a recruitment

project in Santa Fe, New Mexico – called the Heart Gallery. Agencies across the country strive to find homes for waiting children. In Central Texas alone, there are 500 kids daily waiting for adoption. These are kids of all ages, ethnicities and about 50% are members of sibling groups. The Heart Gallery is an effort to humanize these children – putting a picture with a story. A recent survey conducted in the Austin area revealed that approximately 84% of those surveyed did not know you could adopt from the foster care system. In addition, there are a host of myths and misconceptions about children in foster care. These portraits are step one in the process of bringing these children to life.

Fifty-five photographers volunteered their time and talents to this effort – helping not only to photograph the children, but to join the effort in promoting the adoption of children in foster care. The goal of this project was to capture the personalities and characteristics of these children, offering a glimpse into their soul, and ultimately, prompting potential families to inquire about adoption. As you can see from the pictures, these are children with hearts, and most importantly, hope.
