This is the story of how one man fullfilled his promise to an impoverished Afghanistan village to return and build them a school and how that first school eventually turned into fifty-five schools, many especially for girls, in some of the wildest parts of Pakistan and Afghanistan. This book has been a joy to read. Try it !

For those who want to get an early start with their reading, November's selection is "Water for Elephants" by Sarah Gruen. It is the time of America's Great Depression and Jacob Jankowski, a veterinary student who almost earned his degree, is orphaned and penniless. Fate casts him aboard a rickety train, home of the Benzini Brothers' "Most Spectacular Show on Earth," where he is put in charge of caring for the circus menagerie. Among the memorable characters of this circus world, Jacob meets Marlena, the beautiful equestrian star who is sadly married to August, a charismatic animal trainer with a mean streak; and Rosie the elephant who is supposed to star in a new act except that Rosie can't follow

instructions, and appears untrainable until Jacob discovers a way to reach her. What follows is the story of Jacob's life midst the glitz, glamour, murder and mayhem that was life under the Benzini Brothers' Big Top – stories recounted from the memories of the now ninety-something year old Jacob as he struggles to maintain his sanity in a nursing home.

## **Security Warning**

Courtyard Residents PLEASE TAKE NOTE that there were at least two attempted car thefts and/or break-ins in our neighborhood in late August. The police were called to the scene and reports were filed. For this reason, the Board would like to urge everyone in the Community to be "on guard" -- not fearful -- just watchful and alert. Keep an eye out for one another and for our belongings. Note that these break-ins happened to cars that were parked on the street. With that in mind, we further urge everyone to make an effort to avoid parking in the street; lock the doors and close the windows of vehicles left outside – whether in the driveway or the street; do not leave items left in your vehicles in plain view; and keep garage doors closed when not in use. Bottomline: be aware of what's going on around you and report any suspicious behavior to the police.

Finally, because of its location and size, the Courtyard has tended to have fewer incidents of crime than many of our area neighbors. Clearly, however, we are not immune, and one of the best lines of defense is an active neighborhood watch system. Please contact the Security Committee chairperson or any Board member if you have any ideas or suggestions about ways to make our neighborhood safer and/or would be interested in participating in a neighborhood watch program.

#### Area Developments – Update

#### Project: Widening of FM 2222 and replacement of low water bridge on FM 2222 at Lakewood Drive.

As you may recall, in August 2006, the Texas Department of Transportation (TxDOT) estimated the above noted project would be ready for construction letting within a year, by August 2007. This time period allowed roughly six months for final acceptance of its right-of-way (ROW) maps and acquisition of the necessary ROW and six months to move the utilities currently in the way of the project to the edge of the new ROW. TxDOT indicated that construction should begin within a few months after bids were let and was scheduled to then take approximately fifteen to eighteen months to complete.

On September 5, 2007, I was notified by TxDOT that it was still waiting for the City of Austin (City) to contribute its 10% of the funding for the purchase of the ROW and until that money was received, the project could not move forward. TxDOT expected to receive the City's contribution sometime this fall, but the project's schedule is now roughly a year behind and would not be let for construction until August of 2008.
