#### **Town Hall Meeting Summary**

November 15, 2007 6:30 pm MUD Building

- 1. The Board reviewed improvements made in 2007. These included: pool resurfacing, the purchase of additional chairs for the pool, pool storage units, video surveillance equipment/installation, multiple irrigation repairs, tree trimming of all common area oak trees, installation of temporary lighting at Jones Road and the installation of a sidewalk on our vacant lot.
- 2. The Board discussed 2008 community improvement plans. These include the repair of the damaged canopy at the pool (\$2,360), repainting stripes on pool parking lot, pressure washing pool area, entrances and columns, pool restroom repairs, on-going irrigation repairs and investment in our long range landscape plan. In addition consideration will be given to purchasing additional lounge chairs for the pool, painting of pool building and pool room, pool parking lot lighting, installation of lighting at Round-Up entrance where none exists, the addition of some type of amenity at our vacant lot, information signs at

- 3. Projected need for our cash reserve include a pool filter (\$3,708), pool pump (\$1,133), pool chlorinator (\$412), spa filter (\$1,288), spa pumps/motor (\$567), landscape backflow values (\$8,755) and irrigation system timer clocks (\$6,631).

- Significantly reduced Legal Fees (Willow Pointe vs. developer litigation resolved late 2005)
- Developer settlement (\$45K) was posted in early 2006.
- Management Company Fees (less than prior years)
- Landscape maintenance (less than prior years due to implementation of long range plan)
- Reduced water costs
- Improved collection of assessments. Total assessments billed in 2007 = \$263,424. Collected year to date November = \$256,425. Outstanding for 2007 = \$6,999.
- Per the Willow Pointe Collection Policy all accounts that fail to pay are turned over to the Association Attorney for Legal Action. Monthly status reports are reviewed by the Board of Directors. Total accounts in collection = 8 Legal Action (6), Payment Plan (1), Bankruptcy (1).
- 5. Officer Stokes Harris Country Sheriff. Officer Stokes encourages the community to report any unfamiliar vehicles or individuals seen in the community and to keep yards well lighted during evening and nighttime hours. He also encourages us to stay in our car until after our garage door has closed, keep our garage doors closed at all times and to get the phone numbers of neighbors in your neighborhood.
- 6. President Decker discussed the shed/play fort amendment issue. He stated the kick-off would be scheduled after the first of the year. He also spoke to the issue of front yard trees. The covenant calls for two trees but some yards are smaller than others.
- 7. Open Mike
- Individuals requested that the Board define the process that will be put in place regarding the effort to change the amendment. There is interest in forming a committee.
- Rot Board individuals would like to see the allowance of a 6 ft. 6 inch fence (rot board allowance) published.
- There was a request to review the deed restriction letters as some are not clear (language).
- Individuals would like to see some verbiage/criteria developed around front yard trees. Interest was expressed in having an outside or unbiased opinion.

#### **Keeping Our Drains Clean**

Please remember that you are responsible to keep the curbs in front of your property clean and free from yard and other debris. The curbs direct rain water to the bayou and water retention pond system. The rain water needs a clean path to efficiently flow to the drains. Grass growing in the curbs and drains inhibits the free flow and contributes to the high and standing water in parts of the neighborhood after a heavy storm.

Moreover, it is illegal to sweep or blow any lawn clippings, leaves or other debris into the county storm drains. Please remind your lawn crews to stop this practice of blowing into the drains.

# Recipe of the Month

#### Great Football Treat Heaven on a Cracker

16 oz Philadelphia cream cheese, softened 2/3 c mayo

8 oz shredded Swiss cheese

3 green onions, finely chopped

16 slices of cooked, crumbled bacon

1 sleeve of Ritz crackers, crushed

Soften the cream cheese in the microwave. Combine the softened cream cheese with the 2/3 c of mayo, 8 oz Swiss cheese and the green onion. Once all are mixed, put into a microwave safe dish. Mix together bacon and crackers. Put bacon/cracker mixture on top of the cheese and microwave it on high for 2 to 3 minutes. Serve with Frito's, crackers, tortilla chips.

I use light cream cheese and light mayo and I use already cooked bacon, just heat and crumble.

#### **Do You Have Too Much Stuff?**

A lot of people have too much "stuff". A person can drive through any neighborhood, including Willow Pointe, and notice garages full of "stuff". These homeowners cannot put one car in the garage, much less two. Some people park very expensive cars on the street or in the driveway.

A car is an investment and should be protected. The garage was designed for the storage of automobiles. Parking your car in the garage protects it from the weather and vandalism. It is a good feeling to get in a car in the morning that is dry from the overnight moisture. It is really nice to pull into the garage during a rain storm. Some families have cars valued at half the price of the home parked outside all the time.

What is a homeowner to do with all that "stuff" so a car can be parked in the garage? First you need to sort through all that "stuff" to see if it is important enough to keep. Separate the useful and important "stuff" from the Junk. Donate any useful, but not needed "stuff". Goodwill Industries, on Jones Road, will take a wide variety of reusable merchandise. You take it over there and a courteous young man will unload your car for you.

After getting rid of the unneeded "stuff" the next step is to organize what is left. There is usually room in the garage for shelving and cabinets. Spend a little time planning where these storage spaces can be placed.

If there is more stuff than will fit in the garage, take a look at your attic. Most of the homes in Willow Pointe have access to the attic. The ideal spot is above the garage. Some two-story homes do not have an attic above the garage. To gain access to the attic space you may have to install a stairway. The disappearing stairway is best because it takes no floor space. You will have to put a floor in the attic to store your "stuff" on. Be careful of the weight of what you store in the attic. It can be clumsy carrying some things up or down the stairs. Lighting may also be necessary.

If you have additional things to get out of the garage, consider a storage building in the back yard. A storage building is a great place for lawn equipment. Check the deed restrictions before going too far with this plan. There are limitations that you agreed to when you purchased your home in Willow Pointe. The homeowners board is corrently working on a change in the restriction concerning storage buildings.

Storage buildings come in a lot of styles, colors and construction materials. There are wood and metal buildings. When choosing a building, think of maintenance. Some require a lot less maintenance than others. Also choose a style that does not detract from the landscape of the back yard.

The last resort to cleaning out the garage is to rent an off site storage space. If a lot of the "stuff" in your garage is rarely needed, check out a nearby storage place. Most of these places have enclosed, secure spaces for rent on a monthly basis. Sometimes the cost of this solution is incentive enough to make a homeowner decide if he really needs to keep all this "stuff".

Once you start enjoying the benefits of having an organized garage you will wonder why you didn't do it a long time ago.





#### **Garbage Service**

Most everything you would want to know!

Information provided by Allied Waste Services

- 1. Weekly collection of household garbage occurs on Monday and Thursday. All trash must be ready for pick-up buy 7.a.m. IF THE COLLECTION DATES FALLS ON A HOLIDAY THERE WILL BE NO GARBAGE COLLECTION AND THERE IS NO MAKE UP FOR THE MISSED DAY. Please do not place your garbage out until the morning of collection.
- 2. Recycle box collection occurs ONLY on Monday.
- 3. All brush; tree trimmings and other wood products <u>must be tied</u> <u>bundled and placed on the curb</u>. **Bundles should not exceed 4 feet in length or 50 pounds in weight**. If your items are not bundled, tied or larger, they will not be collected.
- 4. Heavy trash is collected curbside on the LAST Thursday of each month. Heavy trash consists of items such as refrigerators, stoves, hot water heater, furniture, moving boxes etc. <u>ALL BOXES MUCH BE FLATTENED</u>. An appliance technician must post a notice on refrigerators/freezers/air conditioners stating that Freon has been removed otherwise they will not be picked up.

The following items WILL NOT be picked up

- Construction material
   Car parts
- Tires Cement/bricks
- Paint cansAny hazardous materialMotor OilMetals
- Tree trunks Doors
- 5. If you have questions, please call customer service at 713-635-6666 between the hours of 8 a.m. and 5 p.m. Monday through Friday.
- 6. To request a recycle bin call 713-635-6666 (Customer service). It usually takes about 10 days.

PLEASE KEEP TRASH CANS OUT OF PLAIN VIEW ON DAYS WE DO NOT HAVE TRASH PICK UP.


