Recent improvements to the community:

- The area along Lake Vista between Carriage Glen to Opal Valley: Brush and debris removed, grass and mulch have been installed.
- Treed area on Eden Grove cleared.
- Mulching throughout the community is now completed.
- The Lake has been dyed an aqua color to help with algae. This will not hurt the vegetation or wildlife (fish, turtles and our new resident ducks).
- "Please pick up after your pet" signs have been installed.
- "No Motorized Vehicles Allowed" signs are currently being replaced with new ones.
- Gutters have been installed on the pool house.
- The pool has been resurfaced; additional repairs and maintenance are still underway.
- Estimated start date on the splash pad construction is April 1st.
- Estimated start date for various landscaping updates throughout the community is April 1.

#### **Constable's Corner**

Over the last month, we have responded to calls involving a person(s) entering unlocked or unsecured vehicles and removing property. In each of these incidents, it was clearly obvious that the person(s) responsible were looking for easy items to carry away and given the situation, were able to do so with no detection. It is our desire to deter this activity from taking place within the neighborhoods. With that in mind, we ask for your assistance by following the simple suggestions indicated below:

- Park your vehicle on the driveway or in the garage when possible. A vehicle parked on the street is an easier target than one parked on the driveway.
- Remove or conceal valuables in the vehicle. It is sometimes inconvenient to do this, but a laptop, GPS unit or electronic device visible inside the vehicle makes the vehicle a target.
- Secure the vehicle by locking it and activating the alarm system, if equipped. Any means of detection or deterrence can scare away a thief.
- If the vehicle is entered and property is removed, do not hesitate in contacting law enforcement. It can be very important to examine the vehicle for any evidence which may identify the person(s) responsible before the evidence is removed or contaminated. The opportunity to check a vehicle for fingerprints can be very important in solving the crime.
- Take the time to record numbers that will identify the property you carry in your vehicle such as serial numbers for an Ipod, laptop, etc.
- Close your overhead or walk through garage doors when you are not going to be out front. It takes only a few seconds for weed eater, mower or a set of golf clubs to be taken. If you have a detached garage, be sure to close and lock the walk through door.

Again, these are just a few helpful reminders that may prevent you from becoming a victim. As always, please report suspicious activity in your neighborhood. A simple phone call can help in preventing or solving a crime.

The Village Creek Neighborhood Watch Program is off the ground, but barely. As noted in the March edition of the Village Creek Gazette, the first step in the process is the selection of Block Captains for each street in our neighborhood. We have 54 streets in our neighborhood and so far we have had six people volunteer to be Block Captains. Obviously we need many more volunteers.

Since joining your Board in October, 2007 I have received many emails and even a few phone calls regarding minor robberies and incidents of vandalism in the neighborhood. Many of you have expressed concern and asked what can be done to nip these issues in the bud. The answer is we need to take an active involvement in supporting law enforcement in our neighborhood. Law enforcement alone cannot address these issues. They need "eyes and ears" in the neighborhood to bring incidents to their attention as they occur 24/7. This sends a message to those committing these incidents that we will not stand idly by and watch them as they take advantage of our neighbors and friends.

How do we go forward? Please look at the website and note if your street is not listed with a Block Captain and consider stepping forward to assume that role.

#### Street Construction and Stop Light Update

Final alignment recommendations were approved by Commissioners Court in July 2007. Project initiation is in progress for the ultimate design of a 4-lane concrete boulevard section with storm sewer system. Improvements will be designed and constructed in 2 segments. Segment A between Telge Road and Faulkey Gully and Segment B between Faulkey Gully and SH 249.

A traffic signal with pedestrian signals, ADA wheelchair ramps and crosswalk at Spring Cypress and Village Creek Trail is in the design phase. More information can be found at www.hcp4.net.



#### Long term care: something to think about.

A recent Long Term Care National Poll revealed what people are thinking and doing about long term care. Genworth Financial reports from this poll that many people believe long term care is only for the very old and therefore are prone to ignoring the issues. But what are the important things to know about long term care?

The bottom line: Americans are not planning for possible long term care needs but are concerned about how they will pay for it. The vast majority of Americans are not prepared for the costs of long term care:

- Nearly 6 in 10 Americans (59% of survey respondents) are worried about being able to pay for long term care for themselves.
- 75% (3 out of 4) have made no preparations for their own or a loved one's long term care needs in case it is needed.
- Even if it meant saving \$25,000 a year, only 9% of respondents said they would place a loved one in a nursing home in another part of the state or in a neighboring state.

But the possibility of developing Alzheimer's disease motivates people to plan for LTC. 72% of respondents said that the possibility of developing Alzheimer's disease or another form of dementia is an important motivating factor in planning for long term care.

• The growing incidence of Alzheimer's disease is a motivating factor for long term care planning, especially for senior citizens. When informed of a new report that found Alzheimer's disease

prevalence has increased 10% in the last few years and that someone in America is diagnosed every 72 seconds, roughly half (49%) of survey respondents age 65 or older said the disease was a VERY important motivating factor in planning for long term care. In comparison, only 24% of seniors who were not informed of the recent Alzheimer's disease report were very concerned about being able to pay for long term care.

Consumers incorrectly believe the federal government or their health insurance will pay for their long term care needs

Almost half of survey respondents (44%) incorrectly believe that Medicare or their private health insurance will pay for their long term care needs. Actually, health insurance and the federal Medicare program do not generally cover long term care.

People would prefer long term care in their home

- If given the choice between care in a facility such as a nursing home or an assisted living facility and care at home, 75% (3 out of 4) of respondents would prefer care at home.
- However, 43% of respondents incorrectly believe Medicare or their health insurance will pay for a home health aide.

Survey Information: The survey was conducted March 25-27, 2007 by Public Opinion Strategies. The poll of 800 registered voters across the country and has a margin of error of +3.46% in 95 out of 100 cases.




