Book Club

Meet us at 1 p.m. on October 14 at the Courtyard Tennis & Swim Club to discuss The Zookeeper's Wife. Author, Diane Ackerman, is described as a naturalist and poet. Her previous books have explored the brain, endangered species, and her personal garden. Fascinated by the remembrances of her Polish grandfather about a primeval forest in Poland, Ackerman begins a search for more information. In the process she discovers a diary that supplies many of the details of this book. The diary reveals the heroism of Antonina (the zookeeper's wife) and her husband, in saving more than 300 Jews by housing them in the zoo's cages. Theirs is a historical narrative that could not be more captivating if it were well told fiction. The Zookeeper's Wife is on many of the best of 2007 lists and won the 2008 Orion Magazine Award given for books that present new ideas about our relationship to nature and deepen the understanding of the natural world. Ackerman was a featured speaker at the 2007 Texas Book Festival.

As we approach the holiday season, the Book Group will lighten its reading in October with an unusual mystery, Anarchy and Old Dogs by Colin Cottrell. Set in 1970's communist Laos, the story is told by the national coroner, Dr. Siri Paiboun. While Cottrell includes all the elements of mystery, much humor emerges in the description of a hard line communist bureaucracy, which poorly fits the ancient Laotian culture.

Area Developments — Update Project: Widening of FM 2222 and Replacement of Low Water Bridge on FM 2222 at Lakewood Drive

In August 2006, the Texas Department of Transportation (TxDOT) estimated that the above noted project would be ready for construction letting within a year. This time period allowed roughly six months for final acceptance of its right-of-way (ROW) maps and acquisition of the necessary ROW and six months to move the utilities currently in the way of the project to the edge of the new ROW. TxDOT indicated that construction should begin within a few months after bids were let and was scheduled to then take approximately fifteen to eighteen months to complete.

A year later, September 2007, project organizers were still waiting for the City of Austin (City) to contribute its ten percent (10%) of the funding for the purchase of the ROW and indicated the project could not go forward until that money was received.

On September 10, 2008, the City reported that negotiations had finally begun for purchasing all the necessary ROW to construct the project. The latest schedule has bids to be let in September 2009, and construction beginning shortly after.

Travis County Voter Alert

35 Days and Counting Until November 4 Election!!!

October 1 begins the 35 day countdown to the November 4 elections, and the Travis County Clerk's Elections staff expects this to be an historically high turnout. To help ensure voters are ready for Election Day, the staff prepared the following preparation check-list and suggestions to facilitate the voting process.

1. REGISTER to Vote and UPDATE your voter registration NOW

Deadline to register to vote or update your registration is **Monday**, **October 6, 2008.**

- Newcomers to Travis County must register to vote to be eligible to participate in the election on Tuesday, November 4.
- To avoid unnecessary delays and possibly miss your chance to vote, if you have moved within Travis County or changed your name, you must update your registration with the most current information. Voters who have not updated their records must do so at the polling place before being issued a ballot. On Election Day, voters must vote at the precinct where they are registered, so this means returning to the polling location designated for the previous address if their registration is not current.

While the County Clerk adminsters elections in Travis County, the County Tax Assessor-Collector handles Voter Registration functions. To register to vote, or to update your Voter Registration status, contact

the Travis County Tax Assessor-Collector's Voter Registration office at (512) 854-9473. You may confirm your voter registration status on the Tax Office website: www.traviscountytax.org.

2. VOTE EARLY in Person

Early voting runs from Monday, October 20 to Friday, October 31, 2008


Texas provides for no-excuse Early Voting in Person, and Travis County offers one of the most extensive Early Voting programs in the state. The County Clerk's "retail approach" focuses on securing polling places that voters regularly frequent – such as grocery stores, libraries, and community centers. Taking advantage of early voting – especially during the first few days of the period, is the easiest way to cast a ballot in person.

3. Prepare and Submit BALLOT BY MAIL Application when Eligible.

Who is an "eligible" voter?

 Active-duty military and overseas citizens are eligible to submit a "Federal Post Card Application" (FPCA) to receive a ballot by mail at any time; and

• Beginning Friday, September 5, 2008, Texas law allows the following other "eligible" voters to submit an "Application for a Ballot by Mail." (ABBM) Note, however, that pursuant to state law, applications received prior to September 5 must be rejected.

Registered voters that meet one of the following four qualifications:

- 1. 65 years of age or older;
- 2. Out of the registered county for the entire voting period (Oct. 20 - Nov. 4);
- 3. Disabled; or
- 4. Incarcerated but still eligible to cast a ballot.

Both FPCA and the ABBM forms can be downloaded from the County Clerk's website: www.traviscountyelections), or the Elections staff can mail the applications to voters. Contact the County Clerk's office at 854-4996 for assistance: www.traviscountyelections.org.

4. Confirm Your Polling Place. Site selection will soon be completed for Early Voting and Electon Day polling places. The County Clerk has directed staff to plan for additional capacity and expanded opportunity. Once finalized, the complete list of polling locations will be posted on the Elections' website. At least a few sites change each election, so voters should be sure to check polling locations before heading out to vote.






