#### Take Action Against Criminal Activity

Timarron has minimal criminal activity, however, periodically walkers and neighbors see something unusual. If you see an unfamiliar vehicle or happening, please write down the license plate, nearest address, and do not hesitate to call the police. Allow these experts to make the judgment call. Some examples include:

- Landscape boulders being removed from a neighbor's yard.
- Newly planted flowers removed from either home or Association property right after planting.
- Large gathering of persons or vehicles after Association amenities close. All of the above took place in Timarron and resulted in undue expenses and police reports. Police officers will communicate with the individuals and determine if anyone is committing a crime.

#### Wentwood & Cascades Courts



## CRESCENT ROYALE

#### Front Yard Landscape Schedule

Crescent Royale is a "front yard maintenance" community currently supported by an annual neighborhood assessment. The current maintenance contract applies only to front yard service and defines the basic service standard for the entire community. The Crescent Royale Landscape Service Line is established and dedicated to front-yard landscape concerns (see "bullet" items below).

- Front yard basic services currently include mowing, fertilizing, mulching, trimming, property cleanup including fall leaves, occasional trimming of trees, and weed and fire ant control.
- The contract is currently a twice per year "changing of colors" consists of pulling old flowers, preparing bed, and planting 10-flats of flowers selected by the homeowner from a contractor selection.



bones. Cut each piece in half to make it thinner. Put the breasts between two sheets of wax paper and pound them as thin as possible. Marinate chicken in 1/3 cup soy sauce for 1 hour.

Meanwhile, heat oil in a skillet; saute mushrooms, scallions, and water chestnuts for 5 minutes, stirring frequently. Mix in remaining soy sauce, seasoning, and sherry. Cool.

Spread equal amounts of the mixture on one side of each chicken breast. Fold over and press edges together firmly. Wrap each breast in greased aluminum foil, sealing the edges.

Arrange the packets on a greased rack and grill 4 inches over heat for 20 minutes, turning the packets to cook both sides. Fold back the foil to serve.

NOTE: Smaller version make excellent hors d'oeuvre. Cut the pounded chicken into squares and proceed as directed, but only cook for 10 minutes.

#### Hawaiian Fruit Kabobs (Serves 12)

**Ingredients** 

- 1 16 oz. can pineapple chunks
- 1/4 cup dry red wine
- 2 Tablespoons lemon juice
- 2 Tablespoons vegetable oil
- 1 Tablespoon honey
- 1 clove garlic, minced
- 3 canned Yams
- 3 very ripe bananas
- 12 small white onions
- 12 skewers

#### Directions

Drain pineapple; combine pineapple juice with wine, lemon juice, oil, honey and garlic.

Cut the yams into 2-inch chunks and the bananas in 1-inch thick slices. Add yams, bananas, and onions to marinade. Let stand in refrigerator overnight, or for at least 2 hours at room temperature.

Turn several times; drain, reserving marinade.

Alternately thread pineapple, yam, banana, and an onion, then repeat, ending with a cube of pineapple, on 12 skewers. Grill 5 inches above heat for 8 to 10 minutes, turning skewers to brown all sides, brushing with marinade as vou turn.


## YOU AND YOUR CREDIT

#### This month's article we'll focus on the steps you can take to preserve your good credit rating or to establish it.

First and foremost, good **Pay Habits** is the key to preserving or creating a good credit rating and score. For those that don't have the means to buy whatever they want whenever they want, this requires good discipline. A good guideline for years has been to not spend more than 28% of your monthly gross income on house or rent payment. Additionally, your total debts (installment and revolving) should not exceed 36% of your gross monthly income. When relating your pay habits to your credit score remember, the number of late payments on your credit file represents about 35% of your overall credit score.


#### WENTWOOD POOL


