# Presidents Message 2011 Assessment

All homeowners should have received their 2011 annual Willow Pointe Assessment from Randall Management. As a reminder, the decision was made to NOT increase the 2011 assessment, maintaining it at \$448. With the assessment notice, you should also find a copy of the Collection Policy and the Amended By-Laws filing. A copy of the amended By-Laws is available on the Willow Pointe website at www.willowpointe.org under the 'Documents' section.

## Late Fees

All assessments are due January 1st and are delinquent if not received thirty (30) days after the due date. The new policy states that approximately forty-five (45) days after the due date, all delinquent Owners will receive a late letter requesting payment. An interest charge of ten percent (10%) will be posted to the Owners account, together with a \$35 administrative charge for the late letter, and an administrative fee of \$30 per month for each month the account remains unpaid.

As always, all homeowners who cannot pay the assessments by January 31st may setup a payment plan by contacting Randall Management and pay the assessment over a period of three months.

Board of Directors Meeting Tuesday, September 7, 2010

#### **MINUTES**

The Willow Pointe Homeowners Association, Inc., Board of Directors met for the monthly meeting of the Homeowners Association at the Willow Pointe Pool located at 9919 Willow Crossing, Houston, TX 77064.

#### **Board of Directors:**

#### **Present:**

Scott Ward, President Steve Mueller, Treasurer Brenda Jackson, Secretary Greg Decker, Director at Large

#### Absent:

Hollis Miles - Vice President

#### **Management Company:**

Jane Godwin, Randall Management Janet Bonura, Randall Management

#### Call to Order:

Scott Ward called the meeting to order at 6:35 p.m.

#### Establish Quorum - Roll Call:

With a majority of the Board of Directors present, the quorum was established. The Directors in attendance are listed above.

#### Adoption of Agenda:

The agenda was reviewed and a motion was made by Scott Ward, seconded by Greg Decker, and it was unanimously decided to approve the agenda as presented.

#### Open Forum:

The Open Forum is the time provided for the owners of Willow Pointe to address the Board, ask questions, or make suggestions. There were no owners present.

Approval of the Minutes: August 3, 2010 Board of Directors Meeting and the Executive Session of the Board of Directors- The August 3, 2010 minutes were presented for review. A motion was made by Greg Decker, seconded by Brenda Jackson, and it was unanimously decided to approve the minutes as presented.

#### Committee Reports: Modification Committee – No report was given.

Newsletter Committee – Scott reported that he omitted the garage sale announcement and will place signs throughout the community.

**Web Report** – It was reported that updates are going smoothly.

#### Courtesy Patrol & Crime

**Watch** – Brenda announced that there are currently three volunteers for the hosting a National Night Out event on the respective blocks. She will continue to campaign for volunteers and several Board Members volunteered to take photos of the various gatherings on each block.

# **Landscaping Committee** – No report was given due to holiday. However, it was reported that two lights are burnt out at Round Up and Willow Crossing.

#### **Management Report:**

Financial Report - Jane Godwin reviewed the financial statement for the month ending August 31, 2010 in great detail. The following are the account balances as of August 31, 2010; the Prosperity checking account balance was \$45,204. There was \$60,000 operating transfer placed in the Bank of America Money Market account. These funds are designated for 2010 operation, but placed in the money market accounts to earn additional interest until the funds are needed for operation. The reserves located at Prosperity, Smith Barney, and Bank of America Money Market accounts total \$212,945. This balance does not reflect the operating transfers. The administrative expense for the month was \$2,528, Utilities were \$5,878, Grounds Maintenance was \$7,297, and Community Services were \$324. The Total Expenses for the month of August were \$19,235

and year-to-date the total expenses for the Association are \$163,862, which is \$28,083 under budget.

**Collection Report** – Jane reported that there were \$448 of the 2009 Assessment fees which have not been collected. The Association is 99% collected for 2009 and with \$7,276 outstanding the Association is 97% collected for 2010.

**Legal Report** – Janet presented the updated legal report from Casey Lambright's Office. Updated photos of all uncorrected deed violations already with the attorney were reviewed and discussed. The Board of Directors instructed RMI on how to proceed with those accounts.

# **Deed Restriction Report** – The Board of Directors reviewed the deed restriction report. There were several accounts under Board Review. The Board reviewed these items and instructed Randall Management on how to proceed.

#### Unfinished Business: Various Landscaping & Sprinkler System

**Improvements**- Steve Mueller presented several bids for review and comparison. Each one was addressed and feedback was provided. Steve is to request revised bids for better comparison as there were many inconsistencies. Work to be included in each proposal is to install a 65 gallon Crepe Myrtle at Round Up and Willow Crossing, additional Oleanders and existing sprinkler system repairs at the sewer plant, and installation of Oleanders and additional sprinkler system at the Trail Ridge entrance next to the columns. A motion was made by Greg Decker, seconded by Brenda Jackson, and it was unanimously decided to set a budget not exceed \$9,000 and to award the entire project to the best bid. The Board

authorized Steve Mueller to review the revised bids and award the contract.

#### Miscellaneous Repair Bids Pool/ Park Areas-

Janet presented several bids for work to be completed in and around the pool and park area such as replacing the storage room door, repairs the light pole in the park area, and repairing and repainting the pool's perimeter fence. A motion was made by Greg Decker, seconded by Brenda Jackson, and it was unanimously decided to accept the bid presented by DeLeon Quaility Construction with minor changes.

#### **New Business:**

#### Crape Myrtle at Round Up & Willow Crossing-

Steve Mueller presented a bid to replace the missing Crape Myrtle with a 65 gallon plant. A motion was made by Scott Ward, seconded by Brenda Jackson, and it was unanimously decided to replace the missing Crape Myrtle.

**Voting Registration Fraud**- Brenda reported the recent public discussion of fraudulent activity at the voting polls. Authorities have requested that we enlighten our residents of this risk and encourage them to take additional precautions to protect their personal information and privacy.

**2011 Budget**- Jane presented the 2011 budget for review and edits. A motion was made by Scott Ward, seconded by Greg Decker, and it was unanimously decided to accept the 2011 budget with minor edits.

**2011 Annual Assessment**- Jane informed the Board of Directors that Willow Pointe was maintaining a strong financial position and there was no need for an increase. A motion was made by Brenda Jackson, seconded by Greg Decker, and it was unanimously decided to set the 2011 Assessment at \$448 which is the same assessment rate as 2010.

#### **Adjournment:**

With no further business to discuss, a motion was made, seconded, and it was unanimously decided to adjourn the meeting at 8:21 p.m.


