If you are experiencing an issue with mosquitoes that you would like to report, please call 979-864-1532 to make a report and we will get to your area as soon as possible.

County Spray trucks operate from 8:00 PM until 4:30 AM Monday through Friday.

Brazoria County Mosquito Control District uses both ground and air equipment to spray for adult mosquitoes. ULV trucks are a common sight throughout the summer and fall months. They provide localized relief for residences of Brazoria County. When there is a widespread outbreak or when the landing rate counts begin to climb, we also use aerial spraying. The length of relief from adulticiding is only temporary and depends upon many factors.

Mosquito Control:

What You Need to Know About Truck Spraying

Spraying insecticides from a truck is one way to safely kill mosquitoes in an area, especially when people in the community are getting sick from mosquito bites or are unable to enjoy the outdoors due to high levels of mosquito activity. There are different types of Mosquito Control methods and truck mounted adulticide is just one tool that is utilized in the fight to keep Mosquitoes at a tolerable level.

Truck spraying is used to:

- Control and reduce the number of mosquitoes that can spread viruses and the population of pestilent mosquitoes.
- Reduce your chances of getting infected with viruses and allow you to enjoy the outdoors.

What are mosquito control trucks spraying?

Mosquito control trucks spray very small amounts of insecticide into the air to kill mosquitoes. This spray is a fine mist that acts as a fog in the area. We use a product that is approved by the EPA for this specific use.

What does the insecticide spray do?

Adulticide sprays immediately kill flying mosquitoes. This reduces the population of biting mosquitoes. It also helps in the control of breeding because these adults will no longer lay eggs.

When does spraying occur?

Spraying takes place between dusk and dawn when mosquitoes are out looking for a blood meal. Most other beneficial flying insects are not actively foraging at this time.

How often do communities spray?

During the summer months when mosquitoes are active and the population becomes higher than the tolerable amount. The program has once a week applications. In the case of an outbreak or increased pressure from flooding the application intervals can be raised.

Is the spray harmful to people, pets, animals, or the environment?

No, when done correctly, truck spraying will not harm people, pets, animals, or the environment.

What should I do during or after spraying?

Spraying is safe. You do not need to leave an area when truck spraying for mosquito control takes place. If you prefer to stay inside and close windows and doors when spraying takes place you can, but it is not necessary. If you are having any type of health problems after spraying, contact your doctor or healthcare provider. The spray does not harm pets, but you may choose to bring them inside when spraying occurs.

Flooding: How to Protect Your Family & Finances

In many areas, flooding is the most common and costly natural disaster—and it can happen here. Just one inch of water in your home or office can cost thousands of dollars in cleanup and replacement costs, including drywall, baseboards, floor coverings and furniture. You may think you're covered, but many homeowners' insurance policies do not cover flooding.

Here are several reasons to talk to an insurance agent now about flood insurance.

- There is usually a 30-day waiting period before coverage begins.
- Coverage is relatively inexpensive.
- Renters can buy flood insurance for personal belongings or business inventory.
- Basement coverage includes cleanup expense and repair or replacement of items such as furnaces, water heaters, washers, dryers, air conditioners, freezers and pumps.
- You do not have to repay flood insurance benefits as you do with disaster-related assistance loans.
- You can receive payments for flood-related losses even if no disaster was declared.

There are things you can do to prepare your home and family now for flash floods:

- Make a family emergency plan. Emergency preparedness is everyone's responsibility. Write down your plan. Decide ahead of time where you will go if you have to leave and where family members will meet up. Identify an out-of-town emergency contact.
- Get supplies for an emergency kit. Start with three days' water and three days' packaged and canned food. Add a battery-powered radio and extra batteries. Store in waterproof containers with wheels or that you can lift so you can take them with you. For details about preparing an emergency kit, visit www.ready.gov/america/beinformed/floods.html
- Stay informed about what could happen. During storm season, listen to local media for up-to-date reports on weather watches and warnings. Keep a battery-powered portable radio—with a NOAA weather band—handy in case the power goes out. Choose one.

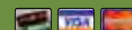
