The Bridgeland Community Supports Veterans, Inc. (BCSVI) thanks The Spencer Company for its very generous donation of \$10,000. The Spencer Company does the landscaping in Bridgeland. We also thank the other contributors who were sparked in part by the generosity of Spencer Company and donated an additional \$6,600.

The President of The Spencer Company is Brad Wander, an Army veteran. Brad joined the Army after graduating from high school in 1978 and served 3 years as a battalion mail clerk, at Fort Hood and while stationed overseas in Ludwigsburg, Germany. Brad credits his experience in the Army for helping to provide him with the leadership skills he needed when he formed his own landscaping company. While in the military, Brad developed a strong appreciation of the men and women who keep the USA free and safe. The Spencer Company's donation is Brad's "thank you" to our service men and women and veterans.

Brad said he grew up in small town in Nebraska that celebrated its veterans and was inspired to join the Army to honor those service men and women who had served before him, and in some cases sacrificed lives in doing so. Brad said that the heroes that he knew as a boy were the men and women that wore uniforms of our great military. Brad credits his military service as being the most influential experience of his life and recommends service in the military for any young person looking to better themselves.

As part of BCSVI "thank you to our vets" in 2020, BCSVI donated \$500 to any requesting veteran who lived within 7 miles of Bridgeland who suffered an economic loss or needed help due to Covid. This program will continue in 2021.

BCSVI accomplished much in 2020. BCSVI donated supplies to Camp Hope, a residential treatment facility for veterans with

PTSD. BCSVI held its annual Memorial Day ceremony as well the Veterans Day festival. Many Bridgeland veterans were grateful to receive a ham from BCSVI in its annual Thanksgiving Ham Giveaway. Sadly, our Annual Run/Walk for your Hero, our major fund-raising event, had to be cancelled due Covid. On a brighter note, BCSVI now has its own website, bridgelandveterans.org which allow us to communicate easily with veterans. In retrospect, BCSVI accomplished much in 2020. We overcame adversity and provided many services to veterans in our community.

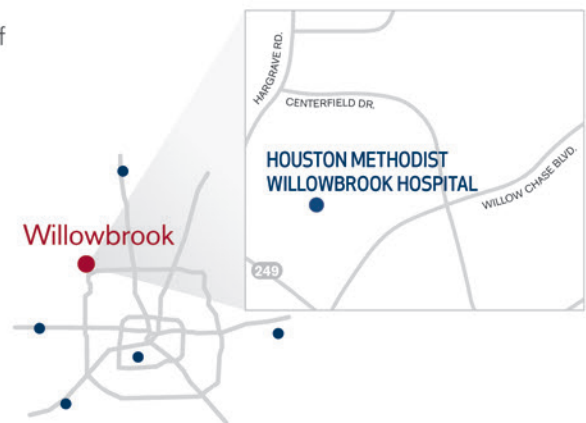

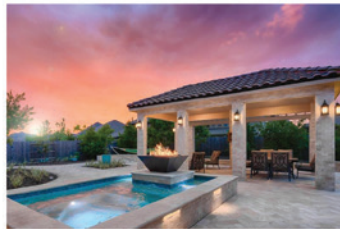
